### 29 YEARS OF ADVOCACY FOR WOMEN'S AND FAMILY ISSUES

### 1994 - 2023

MLAW was established to harness the collective power of women and to create a statewide, nonpartisan, independent coalition of groups and individuals to advocate for progressive legislative initiatives that promote and protect the well-being of women and their families in Maryland.

This call to action for legislative change has resulted in a coalition almost unique in the United States. The annual legislative conference and other activities have energized thousands of women - and male allies - to become engaged in advocacy for important issues affecting Maryland women and families.

The annual Legislative Agenda has included a broad diversity of issues and the organization's advocacy and collaborative efforts have resulted in the **passage of 112 pieces of legislation enacted by the Maryland General Assembly in the last 29 years. In the 2023 Maryland General Assembly session, all 7 bills on the MLAW Agenda PASSED.** 

This extraordinary success has made a significant difference for women and families. It has established MLAW as a powerful voice for women and their priorities in Maryland.

**MLAW provides visibility for legislation affecting women and families.** The fall conference develops our MLAW Legislative Agenda and a legislative briefing during the legislative session introduces the Agenda to advocates and legislators. These events focus legislators' attention on our issues and raise their visibility throughout the state. We distribute the annual Legislative Agenda to every Maryland legislator. In collaboration with our advocacy partners, we submit testimony, advocate for bills, and promote our Agenda through our large e-mail list, website, and Facebook page.

The Maryland Legislative Agenda for Women is proud of its achievements during the last 29 years, but there is more to be done. Join us and help us continue to make a difference for Maryland women and families.

# SPEAKER BIOS

### DELEGATE EDITH PATTERSON

Dr. Edith J. Patterson is a distinguished educator and civic leader currently representing Charles County, District 28, Maryland House of Delegates and serves as the Charles County Delegation Chair. She is the 1<sup>st</sup> Vice President of the Legislative Black Caucus of Maryland and serves on the House Ways and Means Committee and Education Committee. Her scope of governance includes Charles County Board of Commissioners (5 years) and Charles County Board of Education (12 years). Her voting record strongly supports working families and economic development. She also presided as the



Chair of Charles County Democratic Central Committee, elected to the 2004 and 2016 Democratic National Conventions as a Delegate for Senator John Kerry, and then for Secretary Hillary Clinton in addition to a host of other prestigious appointed and elected leadership positions at the state and national levels. Dr. Patterson is a consummate erudite. She holds degrees from Virginia Union University, Bowie State University, and George Washington University. Delegate Patterson is a member of Alpha Kappa Alpha Sorority, Inc., The Links, Inc., Charles County NAACP and Metropolitan United Methodist Church.

### **BROOKE LIERMAN**

### **Comptroller, State of Maryland**

Brooke Lierman is the 34th Comptroller of the state of Maryland and the first woman to be independently elected to one of our state's constitutional offices. After running a strong, policy-focused and grassroots-led two-year campaign, she was elected with over 60% of the vote in November 2022. She is an attorney by training, practicing as a civil rights and disability rights lawyer for many years, and prior to her election as Comptroller, she served for



8 years a member of the House of Delegates representing part of Baltimore City. While in the House, she spent time in leadership roles on both the Appropriations Committee and the Environment and Transportation Committee. Additionally, she was the House Chair for the Joint Committee on Pensions, sat on the Joint Committee on Ending Homelessness, and founded the Maryland Transit Caucus. Brooke successfully passed landmark legislation to invest in and improve public transit and public schools; prohibit the suspension and expulsion of young students; fund evidence-based gun violence prevention programs; aid sex trafficking victims; close loopholes in affordable housing laws, and create the office of statewide broadband. As Comptroller, she is dedicated to creating a Maryland that is more equitable, more resilient, and more prosperous so that all Marylanders can reach their full potential. She and her husband and two school-age children live in Baltimore City.

# SPEAKER BIOS

### VALERIE SHEARES ASHBY

### **President of UMBC**

Valerie Sheares Ashby began as the sixth president of UMBC on August 1, 2022. The first woman to serve in this role, she also holds a faculty appointment in UMBC's Department of Chemistry and Biochemistry.



Sheares Ashby joined UMBC from Duke University, where she had served since 2015 as dean of the Trinity College of Arts & Sciences. As dean, she led the

development and implementation of strategic plans that resulted in significant new investments in faculty recruitment and development, philanthropy, and student engagement, and a realignment of operations that enhanced services and created operational efficiencies. Throughout, she consistently advanced diversity, equity, and inclusion as imperative to excellence in both teaching and research.

Prior to her tenure at Duke, Sheares Ashby chaired the chemistry department at the University of North Carolina at Chapel Hill (UNC) from 2012 to 2015. As a faculty member at UNC since 2003, she held numerous leadership positions and had experience at all levels of academic administration. She served on UNC's Arts & Sciences Foundation Board of Directors and Research Advisory Council and chaired the university's Institutional Conflict of Interest Committee and the College of Arts & Sciences Faculty Diversity Task Force. She engaged in all aspects of the undergraduate educational experience as director of undergraduate studies in the chemistry department, and she directed the UNC National Science Foundation Alliance for Graduate Education and the Professoriate. Sheares Ashby was instrumental in UNC's collaboration with UMBC to launch the Chancellor's Science Scholars Program, which was among the earliest replication pilots by a research university of the Meyerhoff Scholars Program.

She began her academic career in 1996 as an assistant professor at Iowa State University and was promoted to associate professor in 2002. At Iowa State, Sheares Ashby served as a mentor for the Iowa State University Program for Women in Science & Engineering, a summer research program for undergraduate and high school students.

As a researcher, Sheares Ashby has focused on synthetic polymer chemistry, with an emphasis on designing and synthesizing materials for biomedical applications such as X-ray contrast agents and drug delivery materials. She is the recipient of the National Science Foundation Career Development Award, DuPont Young Faculty Award, and 3M Young Faculty Award, as well as numerous teaching and service awards, including the UNC Chapel Hill General Alumni Association Faculty Service Award and the Bowman and Gordon Gray Distinguished Term Professorship for excellence in undergraduate teaching and research. In 2022, Women of Color Magazine named Sheares Ashby its Technologist of the Year.

She received her B.A. and Ph.D. degrees in chemistry from the University of North Carolina at Chapel Hill and completed postdoctoral research at Johannes Gutenberg Universität Mainz in Germany as a National Science Foundation Postdoctoral Fellow and NATO Postdoctoral Fellow.


